

**TOWN OF ARGYLE, TEXAS  
ORDINANCE NO. 2025-39**

**AN ORDINANCE OF THE TOWN OF ARGYLE, TEXAS, DECLARING THE CANVASS AND RESULTS OF THE NOVEMBER 4, 2025, SPECIAL ELECTION HELD FOR THE PURPOSE OF DETERMINING WHETHER THE TOTAL SALES TAX COLLECTED WITHIN THE TOWN LIMITS IS TO BE SET AT 2.0 PERCENT, AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council ("Council") on July 21, 2025, Town Council called a Special Election, to be held on November 4, 2025, to allow voters of the Town of Argyle (the "Town") to vote and consider a referendum on the increase of the total sales and use tax should be increased to two (2.0%) percent; and,

**WHEREAS**, the Council reviewed and investigated all matters pertaining to the Special Election (the "Election"), including the calling, notices, election officers, holding and returns thereof; and,

**WHEREAS**, the Council hereby canvasses the returns of the Special Election, at which there was submitted to all resident, qualified voters of the Town for their action on the following proposition:

*Proposition A:*

*Shall the Town of Argyle adopt a local sales and use tax in the Town of Argyle town limits and in special purpose annexation areas at the rate of 2 percent (2%)?*

*"Deberá el Pueblo de Argyle adoptar un impuesto local sobre ventas y uso dentro de los límites de la ciudad de Argyle y en las áreas de anexión de propósito especial a una tasa del dos por ciento (2%)?"*

and,

**WHEREAS**, the Council has diligently inquired into the poll lists and the official election returns which were duly and lawfully made available to the Council by the election officials holding and conducting such Election; and the official election returns showing separately the votes cast in the Election; and,

**WHEREAS**, from these returns, the Council hereby finds that the following votes were cast in the Special Election by voters who were resident, qualified voters of the Town:

**NOW THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ARGYLE, TEXAS:**

I. **Election; Returns; Canvass.** The Council officially finds, determines, and declares that the Election was duly and properly conducted, that proper legal notice of such Election was duly given in the English language and the Spanish language (to the extent required by law), that proper election officers were duly appointed prior to the Election; that the Election was duly and legally held, that all resident, qualified voters of the Town were permitted to vote at the election, that due returns of the results of the Election were made and delivered, and that the Council has duly canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America, and the order calling the Election.

II. **Election Results for Proposition B.** The Council certifies that a MAJORITY of the resident, qualified voters of the Town voted FOR the increase in the total sales and use tax collected within the Town limits to two percent (2.0%).

III. **Effective Date.** This Ordinance is effective immediately upon its passage and approval.
